

NOTE:-

- a) Candidates furnishing SEBC certificate which is issued more than 03 years prior to the date of submission of online application, shall not be considered under SEBC category.
- b) Experience has shown that candidates obtain SC/ST/SEBC certificate etc. prior to the date of application and upload the same along with online application. Such certificates sometimes get cancelled subsequently. If the cancellation of certificate is detected at any subsequent stage, the candidature of such candidates will be cancelled under that category.
- c) In case of non-availability of eligible/suitable women candidates belonging to the respective categories, the unfilled vacancies of that category shall be filled up by eligible or suitable male candidate(s) of the same category.
- d) Exchange of reservation between Scheduled Caste and Scheduled Tribe will not be considered in the event of non-availability of eligible and suitable S.C. / S.T. candidates.
- e) The number of vacancies to be filled up on the basis of this recruitment is subject to change by the Government without notice, depending upon the exigencies of public service at the discretion of the State Government.

3. AGE:

A candidate must have attained the age of not less than **21(twenty one)** years and not above the age of **45 (Forty five)** years as on the **1st day of January 2025** i.e. he/she must not have been born **earlier than 2nd January 1980** and **not later than 1st January 2004**.

The upper age limit prescribed above shall be relax-able by 5 (five) years for candidates belonging to the categories of Socially & Educationally Backward Classes (S.E.B.C), Scheduled Castes (S.C.), Scheduled Tribes (S.T.), Women & Ex-Servicemen and by 10(ten) years for **Persons With Disabilities category, whose permanent disability is 40% or more.**

Persons with Disabilities belonging to the categories of SEBC/SC/ST shall be eligible for cumulative age relaxation benefit of 15(fifteen) years.

Provided that, the upper age limit shall be relaxed up to 05(Five) years in case of in-service doctors serving on ad hoc basis or contractual basis under the Government or Government undertakings, as the case may be.

Provided that a candidate who comes under more than one category mentioned above, he/she shall be eligible for only one benefit of upper age relaxation, which shall be considered most beneficial to him/her.

(SAVE AS PROVIDED ABOVE THE AGE LIMITS PRESCRIBED CAN IN NO CASE BE RELAXED).

Date of birth entered in the High School Certificate or equivalent certificate issued by the concerned Board/Council will only be accepted by the Commission.

4. EDUCATIONAL QUALIFICATION:

(A) In order to be eligible for direct recruitment, a candidate must –

- (i) Have acquired a Post Graduate Degree in the concerned Broad Speciality or any other equivalent degree or qualification prescribed by the MCI/NMC from time to time.
- (ii) Those candidates who have undergone Diplomate National Board training in concerned subject are also eligible for the post of Assistant Professor subject to fulfilling of any other criteria regarding Diplomate National Board, prescribed by MCI/NMC from time to time in force.
- (iii) The candidates who are already appointed as Assistant Professor in a Medical College without experience as SR as per previous guidelines before 08.06.2017 shall not require the one year experience as SR for applying for Assistant Professor in another Medical College.
- (iv) The candidates who are already working as Asst. Professor before 08.06.2017 to undergo SR ship, they are exempted from the teaching experience requirement of one year in the concerned subject.

6. **METHOD OF SELECTION:**

A. The selection of candidates for recruitment to the posts of Assistant Professor in Broad Speciality shall be made on the basis of **Written Test** as per the guidelines enumerated in the Odisha Medical Education Service (Method of Recruitment and Conditions of Service) Rules, 2021.

Provided that the recruitment may also be made by way of selection from amongst the Assistant Professors in any other Broad Speciality subject, having requisite qualification in the concerned Speciality subject to the condition that seniority in the Broad-Speciality in the said discipline, as the case may be, shall be determined from the date of appointment in the new discipline in accordance with the placement given by the Commission, and accepted by the Government.

Provided further that in case of non-availability of MD/MS/DNB candidates in the disciplines of Anatomy, Bio-chemistry and Physiology, non-medical teachers, with M.Sc. in Medical Anatomy, Medical Bio-chemistry and Medical Physiology (as applicable) along with Ph.D. in Medical Anatomy, Medical Bio-chemistry and Medical Physiology (as applicable) (**SECTION 3.3 and SECTION 6 TABLE 1B OF NMC TEQ 2022**) may be appointed to the extent of 15% (fifteen per cent) of the total number of posts in these disciplines (As per prevalent NMC Norms).

NOTE: *Candidates of non-medical teachers/stream for the disciplines of Anatomy, Bio-chemistry & Physiology will be shortlisted for document verification and eventual selection, ONLY in case of non-availability of required number of medical teachers/stream candidates even if they secure more marks in the written examination.*

According to Schedule-II of NMC (Undergraduate Medical Education Board) notification dated. 16.08.2023, in the department of Anatomy, Physiology and Biochemistry non medical teachers may be appointed to the extent of 15% of the total number of posts in the department subject to non-availability of medical teachers.

B. MODE OF WRITTEN EXAMINATION:-

- (i) The written test shall be of **total 200 marks**.
- (ii) The **total No. of questions shall be 200** and will be of Multiple-Choice Questions (**MCQ**) pattern with OMR evaluation.
- (iii) **Each** question shall carry **one mark**.
- (iv) There shall be negative marking for wrong answers. For each correct answer, **01(one)** mark will be awarded. For each wrong answer **0.25 marks** shall be deducted from the marks awarded for correct answers. For un-attempted questions 0(zero) marks will be awarded.
- (v) **Duration of Examination shall be of 3 hours.**
- (vi) **The qualifying marks in the written examination shall be as decided by the Commission.**
- (vii) Candidates securing qualifying marks will be shortlisted for document verification twice the number of advertised vacancies in different categories as per their merit subject to a minimum of 05. If required number of candidates are not found suitable during document verification either because of defects/inadequate documents/lack of eligibility or remaining absent for such verification, etc., the Commission may shortlist and call further number of candidates as per merit for document verification from the list of qualified candidates only.

(viii) **Syllabus:** – (1) For Medical M.Sc. - the approved syllabus for Medical MSc. will be as per the NMC Curriculum of the Broad Speciality.

(2) For Broad Speciality- the syllabus shall be MCI/NMC approved MD/M.S. syllabus for Broad Speciality subjects.

Candidates who are native or resident of Odisha shall be given preference over candidates of other States i.e. when two candidates secure equal marks in the recruitment and one of them is not a native or resident of Odisha, then out of the two, the candidate who is native or resident of Odisha shall be given preference for selection over the candidate who is not a native or resident of Odisha.

The Commission shall prepare a list of candidates in order of merit on the basis of written test, which shall be equal to the number of advertised vacancies;

Provided that, if two or more candidates secure equal marks, then the candidate securing higher marks in MBBS Examination shall find place above the others in the merit list and in case marks obtained in MBBS Examination is also the same, the candidate older in age shall be placed above the younger.

The list recommended by the Commission shall remain valid for a period of one (01) year from the date of its approval by the Government.

Note: - Any details relating to this recruitment like cut-off marks, answer keys, individual marks etc. shall only be declared on the website of the Commission after publication of the final results and select list.

7. DATE OF EXAMINATION:

The Written Examination will be held on **17th August 2025 (Sunday)**. The detailed Schedule and Centre of Examination will be notified in due course.

8. PLACE OF EXAMINATION:

The written examination for the post of Assistant Professor (Broad Speciality) will be held at Cuttack. The programme of written examination shall be notified well in advance.

9. OTHER ELIGIBILITY CONDITIONS:

- i.The candidate must be a citizen of India;
- ii.He/ She must be of (a) good moral character, and (b) good mental condition and bodily health, good physique and active habits and free from organic defects or bodily infirmity so as not to create an impairment in the due discharge of duties;
- iii.A candidate, who has more than one spouse living, will not be eligible for appointment unless the State Government has exempted his/her case from operation of this limitation for any good and sufficient reasons;
- iv.Government servants, whether temporary or permanent, are eligible to apply provided that they possess the requisite qualification and experience and are within the prescribed age-limit as provided under Para 3 & 4 of the Advertisement. They must inform their respective Heads of the Office in writing regarding submission of their application for this recruitment and furnish "No Objection Certificate" during document verification; **So the candidates must obtain NOC well in advance.**
