Online Applications are invited for contractual engagement of the Community Health Officers (CHO) at different Health & Wellness Centres of Uttar Dinajpur district under District Health & Family Welfare Samiti, Uttar Dinajpur purely on contractual basis.

Eligible candidates should apply online as per instruction given below. Only Online Applications uploaded in the recruitment portal of the State Health Website, www.wbhealth.gov.in will be accepted.

It is also to be noted that any kinds of details which is not furnished during online application, will not be considered during document verification and thereafter.

A. Terms of Reference for engagement of B. Sc. Nurses with Integrated course of BPCCHN :

1. Essential Criteria:

- (i) Passed **Integrated course of BPCCHN** included in B. Sc. Nursing in the year **2021 or thereafter** from an institute recognized by **West Bengal Nursing Council**.
- (ii) The selected candidate will be posted as CHOs if she passed the Final year Examination conducted by University recognized by West Bengal Nursing Council.
- (iii) They must have registration certificate/ provisional certificate issued from **West Bengal Nursing Council (WBNC)**.
- (iv) Up to **40 years of age** as on **1st April, 2026**. Age relaxation will be as per Government norms.
- (v) Proficiency in **Bengali / local language & dialect**.
- (vi) Must be a permanent resident of West Bengal.

2. Desirable criteria: Competency in MS Office & Internet

3. The CHOs will be posted in any SC- Suswasthya Kendras of Uttar Dinajpur District

4. **Mode of selection:** The candidates will be selected through merit list based on **written test (85%) and interview (15%)**. The posting will be given after online counselling. The panel list will be valid for one year from the date of publication of panel.

5. The **Consolidated Remuneration** will be **Rs.20,000/-** per month. In addition the CHOs will also get a **maximum incentive of Rs 5000/-** per month as PLI based on approved parameters.



6. If the incumbent proposes to give her work without covering 1(one) month's notice her remuneration will be adjusted accordingly.

B. Terms of Reference for engagement of General Nursing & Midwifery (GNM) /Post Basic B.Sc/B.Sc. Nursing before the year 2021 Nurses for undergoing CPCH Training:

1. **Essential Criteria:**
 - (i) The candidate must have Passed General Nursing & Midwifery (GNM)/ Post Basic B.Sc / B.Sc. Nursing before the year 2021 from an institute recognised by **West Bengal Nursing Council**.
 - (ii) The must have registration certificate issued from West Bengal Nursing Council (WBNC).
 - (iii) Up to 40 years of age as on **1st April, 2026**. Age relaxation will be as per Government norms.
 - (iv) Proficiency in Bengali/ local language & dialect.
 - (v) Must be a permanent resident of West Bengal.
2. **Desirable criteria:** Competency in MS Office & Internet
3. The CHOs will be posted in any SC- Suswasthya Kendras of Uttar Dinajpur District
4. **Mode of selection:** The candidates will be selected through merit list based on **written test (85%)** and **interview (15%)**. The panel list will be valid for one year from the date of publication of panel.
5. The **Consolidated Remuneration** will be **Rs.20,000/-** per month **after posting** in Susathya Kendra. In addition the CHOs will also get a **maximum incentive of Rs 5000/-** per month as PLI based on approved parameters.
6. After selection, the CHOs will be sent to compulsory CPCH training. During their **training period** they will get **Rs. 10,000/-** per month as **stipend**.
7. The candidates shall have to serve at least 03 years in Susasthya Kendra as CHO after successful completion of training, for which they have to sign a bond agreement.  - (ii) They must have registration certificate/provisional certificate from **Paschim Banga Ayurved Parisad (West Bengal Ayurved Council)**.
 - (iii) Upto **40 years of age** as on **1st April, 2026**. Age relaxation will be as per Government norms.
 - (iv) Proficiency in **Bengali/local language and dialect**.
 - (v) Must be a permanent resident of West Bengal.
2. **Desirable criteria:** Competency in MS Office & Internet
3. The CHOs will be posted in any SC- Suswasthya Kendras of Uttar Dinajpur District
4. **Mode of selection:** The candidates will be selected through merit list based on **academic result (85%)** and **interview (15%)**. The panel list will be valid for one year from the date of publication of panel.
5. The **Consolidated Remuneration** will be **Rs.20,000/-** per month. In addition the CHOs will also get a **maximum incentive of Rs 5000/-** per month as PLI based on approved parameters.
6. After selection, the CHOs will be sent to compulsory CPCH training. During their **training period** they will get **Rs. 10,000/-** per month as **stipend**.

1. Only Online applications will be accepted through State Health Website, www.wbhealth.gov.in under E-Governance ('Online Recruitment' menu). Online applications will be found at the Home page of **WB HEALTH Portal** by clicking at left side **Recruitment menu**.
2. Candidates must apply online only after reading the instructions given here below thoroughly and carefully after checking the eligibility criteria given above before submitting the online application.
3. **Important dates for Online Application:**
 - a. **Starting date for Online Registration : 17/02/2026**
 - b. **Last date of Online Registration : 26/02/2026**
 - c. **Last date of Submission of application fees online : 26/02/2026**
 - d. **Last date of Full Submission of Online application form : 28/02/2026****N.B. : Online Registration is mandatory for all online applications.**
4. Cutoff date for calculation of age will be **01-04-2026**
5. **All essential criteria must have been fulfilled on or before the starting date of online application as given above.**
6. Only Online Application uploaded in the recruitment portal of the State Health Website, www.wbhealth.gov.in will be accepted, no need to send the hard copy /print copy of the online application to the office of the undersigned.
7. Application fees (Non-refundable) of **Rs.100.00** (Rupees One hundred) only for UR candidates and **Rs.50.00** (Rupees Fifty) only for the Reserved category must be submitted through Online mode only. **The Online deposition of application fees can be done through Net banking or Credit card/Debit card /UPI.** If the payment is successful then the candidate will be immediately reverted back to the link for Final submission of the Application form by using the **Application ID** already received at the time of Registration. **Candidates are to note that the Application ID generated at the time of Registration is to be noted and kept safely for further use during the online application.**
8. **Online Registration number is to be retained by all applicants for further reference and use. The District Level Selection Committee/District Health & Family Welfare Samiti, Uttar Dinajpur is not liable to give any information about the online registration numbers to the applicants at any point of time.**
9. **Online Application not properly filled up or incomplete Applications are liable to be rejected. Further, if the details furnished in the online application submitted by the applicant differ with the details in the original testimonials, the application is liable to be rejected/cancelled.**
10. **If the online application does not have the signature as well as the photograph of the candidate uploaded, the application is liable to be cancelled.**
11. **After successful submission of the online application, the candidate must download the duly filled up application form and keep a printout ready for future reference.**
12. **The essential qualifications mentioned in the criteria for selection are the minimum criteria and mere possession of the same does not entitle the candidate to claim selection.**
13. All the posts are purely on contractual basis and engagement is valid up to the end of the same financial year in which the candidate joins the post. The tenure of engagement may be further extended on the basis of performance and subject to continuation of the said posts by the State Health & Family Welfare Samiti, West Bengal.
14. The Candidates, who have applied for the position through online, will be invited **first for written test (except BAMS)** after scrutiny. After written test, merit list will be prepared as per marks obtained by the candidates and on the basis of the merit list, shortlisted candidates will be called for document verification in 1:5 ratio (i.e., for 93 nos. posts, total 465 nos. candidates) and if found eligible (as per Point No: 16) during Document verification, will be called for Interview.

15. In case of BAMS, the candidates will be shortlisted on the basis of academic result and will be called for document verification and if found eligible (as per Point No: 16) during Document verification, will be called for Interview.
16. **The following self-attested photocopies of the essential testimonials are to be submitted during document verification and should be considered only after the production of relevant original documents.**
- a. One copy Print out of "**online application form**" duly signed by the candidate in the specified place denoted as "Signature of the Applicant" after the declaration.
 - b. **Mark Sheets & Certificates:** Copies of Mark Sheets (**FOR ALL YEARS if applicable**) & Course Completion **CERTIFICATES** of Madhyamik or equivalent examination, Higher Secondary or equivalent examination, GNM/Post Basic B.Sc. Nursing/ B.Sc. Nursing/BAMS, etc. (as applicable against post/s applied for). Copies of Mark sheets of all semesters/years and certificates in respect of all degrees/diplomas are a must.
 - c. **Competency in MS Office & Internet:** Certificate and Mark sheet indicating Subjects/topics like – MS Office, Internet, etc. of at least 06 Months Duration.
 - d. **Registration Certificate** under WBNC/WBAC (as applicable). The date of registration should be prior to the 1st date of Application.
 - e. **Proof of Date of Birth :** age proof like Birth Certificate / Admit Card or Certificate of Madhyamik Pariksha or equivalent / PAN Card / Passport issued by the competent authority.
 - f. **Residential certificate :** Passport / EPIC (Voter ID Card) / AADHAR Card / Driving License issued by the competent authority.
 - g. **Caste certificate :** SC/ ST/ OBC-A/ OBC-B Certificates issued by the competent authorities of West Bengal only. In case of OBC candidate's category 'A' or 'B' must be mentioned specifically in the caste certificate otherwise the candidate will be treated in "Unreserved" category.
 - h. **EWS certificate :** In case of Economically Weaker Section (EWS), applicants must produce the EWS certificate issued by the competent authority of West Bengal only for the current financial year.
 - i. **Photo identity proof :** Passport or EPIC (Voter ID Card) or AADHAAR Card or PAN Card.
17. **If, at any stage of the recruitment process, if any false information furnished or suppression of any material in the application coming to notice, at any time during the recruitment process or thereafter, (i.e. during written examination, document verification, interview, joining and even during service) and if a candidate is found to have engaged in any misconduct, his/her candidature is liable to be rejected immediately or services would be liable to be terminated without any further notice.**
